



HYNDS LODGE AMENITIES

General Information

- Rental of the Lodge does not include the Amphitheater; you must reserve the Amphitheater separately.
- We will allow a maximum of fifteen (15) tents outside the Lodge, on the Lodge grounds. Day Use and Camping fees will apply to any vehicles associated with the tents. Rental of the Lodge does not include Day Use and Camping fees.
- Park fees are per vehicle. Any vehicle at the Lodge from 6AM – 10PM must pay Day Use fees; vehicles at the Lodge from 10PM – 6AM must pay Camping Fees. Rental of the Lodge does not include Day Use and Camping fees. Fees are waived for Boy Scout groups in the winter season.
- There is electric heat inside the Lodge year-round.
- Water to the Lodge is available May 1st – September 30th; it is turned off during the winter months. Any dates outside this range will not have access to water, including no use of the interior toilets. Guests will need to use the restroom building outside.
- The Lodge has accommodations for thirty (30) overnight guests on the second floor and will accommodate one hundred fifty (150) event guests on the first floor.
- LED candles are preferred; however, candles are allowed if they have something to catch the wax and are **not left unattended at any time**.
- Service Animals are welcome inside the Lodge. Pets are not permitted inside and must be on a leash that is less than ten (10) feet in length when outside.

Main Lodge, First Floor

- Main room has three (3) couches, a few tables, and an open wood fireplace.
- Two (2) bathrooms: Men's has one (1) stall, a urinal and a sink; Women's has two (2) stalls and a sink.
- The kitchen has two (2) refrigerators, a freezer, a microwave, a gas stove and oven, and various cookware. Kitchen linens are not provided; guests are to bring their own.
- The janitorial closet contains toilet paper, garbage bags, and cleaning supplies.
- Nine (9) electrical outlets in the kitchen, ten (10) in the main common area, and two (2) in the hallway/janitorial area.

Main Lodge, Second Floor

- A large, open room with nineteen (19) twin-sized beds. Bedding/linens are not provided; guests are to bring their own.
- There is a fire escape door.
- Four (4) electrical outlets.

Outside Shed Contains the Following for Use

- Ninety (90) folding chairs; fifty(50) padded chairs.
- Three (3), eight (8) foot folding tables; fifteen (15), six (6) foot folding tables.

Exterior

- We will allow a maximum of fifteen (15) tents outside the Lodge, on the Lodge grounds. Day Use and Camping fees will apply to any vehicles associated with the tents. Rental of the Lodge does not include Day Use and Camping fees.
- Four (4) electrical outlets (120 volt) on the power pole.
- One (1) water hydrant.
- One (1) fire ring. Outdoor fires are only permitted in this ring. Any County or State fire restrictions in-place at the time of your visit must be followed.
- A walking trail just over one (1) mile in length is near the Lodge for your enjoyment.
